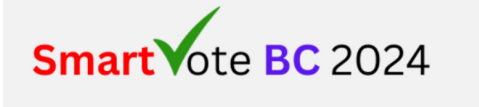
### How the Scorecard works:

|  <b>Bill 44 - Housing Amendment Act</b>                                                               |    |
| Encourages densification by transferring the authority for issuing building permits from the municipal to the provincial government and removes a homeowner's ability to contest decisions about neighbourhood densification. |  <b>Bill 47 – (passed Nov 2024)</b>                                                               |  |
| The provincial government can issue permits for high-rise apartments up to 20 stories near transportation hubs, overriding municipal planning. |  <b>Bill 19 – 2020 Covid-19 Related Measures Act</b>                                              |  |

|  <b>Bill 31 - Emergency Management Act</b> (Passed Nov 2023)                                       |  |
| Allows the Minister to declare an Emergency without proof or substantial evidence and oversight. |  <b>Bill 41 – Declaration on the Rights of Indigenous Peoples Act</b>                              |  |
